NOTICE OF SHERIFF'S SALE OF REAL PROPERTY ON WRIT OF EXECUTION

By virtue of a Writ of Execution issued out of the Circuit Court of the State of Oregon for the County of Lane, in the case of DEUTSCHE BANK NATIONAL TRUST COMPANY, AS TRUSTEE FOR LONG BEACH MORTGAGE LOAN TRUST 2006-9, plaintiff, and JOHN BLOOM AKA JOHN R. BLOOM; SARAH K. BLOOM; SONJA L. SONDERMAYER NKA SONJA L.
