NOTICE OF SHERIFF'S SALE (Real Property)

On November 14, 2017, at the hour of 10:00 AM at the Washington County Sheriff's Office, Civil Unit, Second Floor, Room A-2070, 215 SW Adams Avenue, in the City of Hillsboro, Oregon, I will sell at public auction to the highest bidder for cash or cashier's check, in hand, made out to Washington County Sheriff's Office, subject to redemption, all of the interest that defendants had on August 28, 2009, the date of the Deed of Trust, and also all of the interest that defendants had thereafter, in the following described real property:

LOT 11, LADD ACRES, IN THE CITY OF HILLSBORO, COUNTY OF WASHINGTON AND STATE OF OREGON, TOGETHER WITH AN EASEMENT FOR ACCESS OVER TRACT A, OF SAID LADD ACRES.

Said sale is made pursuant to a Writ of Execution dated July 11, 2017, issued out of the Circuit Court of the State of Oregon for the County of Washington where NATIONSTAR MORTGAGE LLC is plaintiff, and HEATHER R. JENSEN; LADD ACRES HOMEOWNERS ASSOCIATION, INC.; CAVALRY PORTFOLIO SERVICES, LLC; OCCUPANTS OF THE SUBJECT REAL PROPERTY, AND ALL OTHER PERSONS OR PARTIES UNKNOWN, CLAIMING ANY RIGHT, TITLE, INTEREST, LIEN OR ESTATE IN THE PROPERTY HEREIN DESCRIBED is defendant.

PROSPECTIVE BIDDERS, READ THIS SECTION CAREFULLY

Before bidding at the sale, a prospective bidder should independently investigate:

- (a) The priority of the lien or interest of the judgment creditor;
- (b) Land use laws and regulations applicable to the property;
- (c) Approved uses for the property;
- (d) Limits on farming or forest practices on the property;
- (e) Rights of neighboring property owners; and
- (f) Environmental laws and regulations that affect the property.

Conditions of Sale: All potential bidders are subject to inspection of funds prior to or during participation in the auction to qualify as a bidder. Individuals without proof of sufficient funds, or that have not qualified before the start of the auction, will not be allowed to participate. Only U.S. currency and/or cashier's checks made payable to Washington County Sheriff will be accepted. Payment must be made in full immediately upon conclusion of the sale. Only the judgment creditor who obtained the writ may credit bid up to the Writ amount plus allowable costs. The judgment creditor must have cash in hand for any difference above the amount of the Writ and allowable costs.
