**NOTICE OF SHERIFF'S SALE OF REAL PROPERTY

By virtue of a Writ of Execution issued out of the Circuit Court of the State of Oregon for the County of Lane, in the case of BANK OF AMERICA, N.A., plaintiff, and ASHLEY M.
