BEGINNING AT A POINT WHICH IS A DISTANCE OF 161.0 FEET SOUTH 22°7' EAST AND A DISTANCE OF 166.52 FEET SOUTH 67°53' WEST FROM THE NORTHEASTERLY CORNER OF BLOCK 2, KINGWOOD ACRES, POLK COUNTY, OREGON; THENCE NORTH 22°7' WEST A DISTANCE OF 107.2 FEET TO THE SOUTHERLY LINE OF PIEDMONT AVENUE; THENCE SOUTH 35°41' WEST ALONG SAID SOUTHERLY LINE A DISTANCE OF 88.4 FEET TO THE INTERSECTION OF SAID SOUTHERLY LINE WITH THE EASTERLY LINE OF LOT 4, SAID BLOCK 2, EXTENDED NORTHERLY IN A STRAIGHT LINE; THENCE SOUTH 22°7' EAST A DISTANCE OF 60.35 FEET TO A POINT; THENCE NORTH 67°53' EAST A DISTANCE OF 74.76 FEET TO THE PLACE OF BEGINNING, BEING IN THE CITY OF SALEM, COUNTY OF POLK AND STATE OF OREGON.

Individuals without proof of sufficient funds, or that have not qualified before the start of the auction, will not be allowed to participate. Only U.S. currency and/or cashier's checks made payable to Polk County Sheriff will be accepted. Payment must be made in full immediately upon conclusion of the sale. Only the judgment creditor who obtained the writ may credit bid up to the Writ amount plus allowable costs. The judgment creditor must have cash in hand for any difference above the amount of the Writ and allowable costs.
