NOTICE OF SHERIFF'S SALE (Real Property)

On December 12, 2017, at the hour of 10:00 AM at the Polk County Sheriff's Office, Civil Unit, 850 Main Street, Dallas, Oregon 97338, I will sell at public auction to the highest bidder for cash or cashier's check, in hand, made out to Polk County Sheriff's Office, subject to redemption, the defendants' interest in the following described real property:

LOT NUMBERED TWELVE (12), SUNSET RIDGE, IN THE CITY OF DALLAS, POLK COUNTY, OREGON.

Said sale is made pursuant to a Writ of Execution dated September 19, 2017, issued out of the Circuit Court of the State of Oregon for the County of Polk where BANK OF AMERICA, N.A. is plaintiff, and KRISTINE WOOLERY; THE BANK OF NEW YORK, AS SUCCESSOR TRUSTEE TO JPMORGAN CHANSE BANK, N.A., AS TRUSTEE ON BEHALF OF THE CERTIFICATE HOLDERS OF THE CWHEQ INC., CWHEW REVOLVING HOME EQUITY LOAN TRUST, SERIES 2005-I; AND ALL OTHER PERSONS OR PARTIES UNKNOWN CLAIMING ANY RIGHT, TITLE, LIEN, OR INTEREST IN THE REAL PROPERTY COMMONLY KNOWN AS 355 DENTON STREET NW, DALLAS, OR, 97338 is defendant.

PROSPECTIVE BIDDERS, READ THIS SECTION CAREFULLY

Before bidding at the sale, a prospective bidder should independently investigate:

- (a) The priority of the lien or interest of the judgment creditor;
- (b) Land use laws and regulations applicable to the property;
- (c) Approved uses for the property;
- (d) Limits on farming or forest practices on the property;
- (e) Rights of neighboring property owners; and
- (f) Environmental laws and regulations that affect the property.

Conditions of Sale: All potential bidders are subject to inspection of funds prior to or during participation in the auction to qualify as a bidder. Individuals without proof of sufficient funds, or that have not qualified before the start of the auction, will not be allowed to participate. Only U.S. currency and/or cashier's checks made payable to Polk County Sheriff will be accepted. Payment must be made in full immediately upon conclusion of the sale. Only the judgment creditor who obtained the writ may credit bid up to the Writ amount plus allowable costs. The judgment creditor must have cash in hand for any difference above the amount of the Writ and allowable costs.
