6 2. The Deed of Trust executed and delivered by Defendant, Melanie L Wilcher ("Borrower")
7 on or about April 16, 2001 and recorded on April 23, 2011 as Book Vol. M01, Page 17913
8 in the official records of Klamath County, Oregon, is a valid and perfected lien against all of
9 the Property for the amount of Plaintiff's judgment as provided herein.

10 3. The Plaintiff is the holder of the original note dated April 16, 2001 and made by Melanie L
11 Wilcher in the amount of \$85,000.00. A copy of the Note was attached to the complaint as

13 (together the "Loan").

14 4. The interest of each of the Defendant(s) subject to this Judgment and any successor in

16 redemption as provided by Oregon law.
