On or about August 26, 2014, the "General Judgment and Money Award
Against Defendant Vance Wallace Worden" was entered in favor of plaintiff in the
register for this case in the above-entitled court providing a total Money Award in
the principal amount of \$100,000.00, plus interest at the rate of 9% per annum from
August 26, 2014 until paid (the "Judgment").

NOW THEREFORE, IN THE NAME OF THE STATE OF OREGON, you are
hereby commanded to levy on and sell, in the manner prescribed by law for the sale
of real property, upon execution (subject to redemption) real property of the
judgment debtor, Vance Wallace Worden, to include all of the interest which Vance
