## **NOTICE OF SHERIFF'S SALE (Real Property)**

On June 14, 2018, at the hour of 10:00 AM at the Jackson County Sheriff's Office, Civil Division, 5179 Crater Lake Hwy, in the City of Central Point, Oregon, I will sell at public auction to the highest bidder for cash or cashier's check, in hand, made out to Jackson County Sheriff's Office, subject to redemption, all of the defendant's interest, in the following described real property:

BEGINNING AT THE NORTHEAST CORNER OF LOT TWELVE (12) IN THE MACE SUBDIVISIONS IN JACKSON COUNTY, OREGON, ACCORDING TO THE OFFICIAL PLAT THEREOF, NOW OF RECORD; THENCE SOUTH 28° 43' EAST, ALONG THE EASTERLY LINE OF SAID LOT, 75.0 FEET; THENCE WEST 120.0 FEET; THENCE NORTH 28° 43' WEST 75.0 FEET TO THE NORTH LINE OF SAID LOT; THENCE EAST 120.0 FEET TO THE POINT OF BEGINNING.

**PROSPECTIVE BIDDERS READ THIS SECTION CAREFULLY**

**Conditions of Sale: All potential bidders are subject to inspection of funds prior to or during participation in the auction to qualify as a bidder. Individuals without prior sufficient funds, or that have not qualified before the start of the auction, will not be allowed to participate. Only U.S. currency and/or cashier's checks made payable to Jackson County Sheriff will be accepted. Payment must be made in full immediately upon conclusion of the sale. Only the judgment creditor who obtained the writ may credit bid up to the Writ amount plus allowed costs. The judgment creditor must have cash in hand for any difference above the amount of the Writ and allowed costs.**
