



The Respondent/Husband filed his request for attorney's fees one day after the Petitioner/Wife filed hers. The attorneys' hourly rates are reasonable for this community and the complexity of the case.

The parties have two children and were married 11 years. The wife was an unemployed waitress who has returned to school for retraining. Husband has been a securities trader. His employer at the time of trial, Morgan Stanley, gave him an advance, recruitment bonus, or 'forgivable' loan of over \$600,000 that the parties spent during the marriage but that Husband has to repay over time. If Husband remains an employee in good-standing, he is given a bonus before each loan payment to Morgan Stanley is due to cover the loan payment (but with interest added and taxes due for debt forgiveness). The parties viewed this signing bonus scheme differently. It is unique to this field, sports, and entertainment and therefore took more attorney time than usual.



Wife withdrew money from the joint account when she left the family home with the children to set up a small apartment. Husband withdrew large sums of money and was not forthcoming about it, nor in discovery. Husband was not reasonable in his conduct or claims.

For all the reasons stated in Petitioner/Wife's Request for Attorney's fees, she is awarded \$28,000. Petitioner's attorney may prepare the judgment/money award.

Husband's request is denied for all of the same reasons.

2 1. Pursuant to the General Judgment of Dissolution of Marriage filed on April 8, 2014,






