To The Sheriff of Clackamas County, Greetings:

WHEREAS, on August 31, 2018 in the Circuit Court of the State of Oregon for the County of CLACKAMAS County, EQUUS VETERINARY SERVICE, P.C., an Oregon professional corporation, Plaintiff, recovered a General Judgment of judicial foreclosure and money award against CHARLES WILLIAM BULLER and MARTINE CHRISTIANE BULLER, Defendants, for the sum of \$327,889.76 plus prejudgment interest at the rate of 18% per annum on \$327,389.76 from January 31, 2018 until August 31, 2018 (\$34,389.38), plus attorneys fees of \$4,875.00 and a further sum of \$945.00 for costs and

1 disbursements, for a total judgment of \$368,099.14 as of the date of entry on August 31,
2 2018, with post-judgment interest thereon in the amount of \$20,149.65 as of December
3 19, 2018, plus \$125.00 post-judgment costs, which includes the costs of issuance of this
4 writ (\$45.00) and sheriff's execution fee deposit (\$80.00), for a total amount due of
5 **\$388,373.79** as of December 19, 2018, with interest continuing to accrue at the rate of
6 \$181.53 per day thereafter. The judgment required that specific personal property of
7 the Defendants be sold, to-wit:

8 horse semen belonging to the Defendants described as

- 9 a. 89.4 units of semen from the stallion known as RWF Noble Peace
- 10 b. 34.4 units of semen from the stallion known as RMW Free Rein
- 11 c. 3.2 units of semen from the stallion known as Futurity French Command.

14 sell, in the manner prescribed by law for the sale of personal property, the following
15 personal property of said defendants, CHARLES WILLIAM BULLER and MARTINE
16 CHRISTIANE BULLER:

18 horse semen belonging to the Defendants described as

- 19 a. 89.4 units of semen from the stallion known as RWF Noble Peace
- 20 b. 34.4 units of semen from the stallion known as RMW Free Rein
- 21 c. 3.2 units of semen from the stallion known as Futurity French Command

1 to satisfy the sum of **\$388,373.79** (\$368,099.14 total judgment as of date of entry, plus
2 \$20,149.65 post-judgment interest, plus \$125.00 post-judgment costs to date) due on
3 said judgment as of December 19, 2018, plus additional post-judgment interest of
4 \$181.53 per day from December 19, 2018 until the date of sale, plus any additional
5 sheriff's fees beyond the \$80.00 deposit, and make due return hereon within sixty (60)
6 days after you have received this writ.
